## (b) Teaching and learning processes and tools

27. Introducing or improving human rights education in the higher education system requires adopting a holistic approach to teaching and learning, by integrating programme objectives and content, resources, methodologies, assessment and evaluation; by looking beyond the classroom and the higher-education institution to society; and by building partnerships between different members of the academic community and beyond.

(v) Develop multidisciplinary and interdisciplinary human rights academic programmes. 20

<sup>20</sup> Multidisciplinary programmes would include the study, research and engagement with human rights from different disciplinary perspectives, such as philosophy, sociology, languages, international and domestic law, etc. Interdisciplinary programmes would entail the crossing of boundaries between disciplines and the pooling of approaches and methodologies to study, research and engage with human rights with a new integrated perspective.

# **General Principles**

#### Article 1 : Name and definition

a) Name : The Islamic Educational, Scientific and Cultural Organization. It is hereinafter referred to as ISESCO.

b) Definition : ISESCO is a specialized international organization working within the framework of the Organization of the Islamic Conference, specializing in the fields of education, science, culture and communication.

#### Article 2 : Headquarters

ISESCO shall have its headquarters in Rabat, capital city of the Kingdom of Morocco. The Organization may, under a General Conference resolution and upon a proposal from the Executive Council of ISESCO, establish in any other country, centres, offices or institutions which are subsidiary to it or are under its supervision.
